The details of months for academic period will be defined by the Institute and the agency should collect the hostel fees accordingly. The Institute communication on the subject would be the authority for the same.
3. Payment made for a duration of four months will be considered for six months/semester in case of students who have vacation i.e. for 2018-19, 2019-20 batches and specified cases as the case be.
4. Any period of up to 10 days in a month would be ignored for the calculation of monthly fees (2 months 10 days will be considered as 2 months and 2 months 15 days will be considered as 3 months).
