Welcome to Indian Institute of Information Technology Vadodara. Please read the following instructions carefully. The instructions are important in respect of reporting process for the Institute.

Reporting:

JoSAA/ CSAB 2021 core committee has decided that the admission process will be completed in **ONLINE** during 27^{th} October, $2021 - 24^{th}$ November, 2021, as notified in JoSAA portal, for the candidates who have accepted the allotted seat in **JoSAA-2021 rounds**. Admission process for CSAB ($27^{th} - 13^{th}$ December, 2021) will also be held in online mode.

However, separate instructions will be issued for payment of fees to Institute for the period $27^{th} - 13^{th}$ December, 2021, based on payment made to CSAB during **CSAB rounds**.

Candidates will be given provisional admission till verification of requisite original documents is complete.

<u>Commencement of Classes</u>: Classes will commence from 14th <u>December 2021</u>. Details of orientation programme, time table and other details will be uploaded on website separately. Any change will be intimated through website.

<u>Mode of Classes</u>: Classes will be held in hybrid mode (**both online and offline mode**). Only those students who have taken at least one dose of COVID-19 vaccine will be permitted to stay in hostel and attend classes in offline mode. Others will have to attend classes in online mode from their place of stay. As per current guidelines attending classes in offline mode is voluntary.

<u>COVID-19 Vaccine</u> Only those students who have taken at least one dose of COVID-19 vaccine are permitted to stay in hostel and attend classes in offline mode. It will be the responsibility of the

student to take the second dose of vaccine at Gandhinagar. Further, the parents' consent to stay in hostel be included. The format of parent consent is enclosed in this.

<u>Requirement of computing platform/ Laptop/ Notebook computer</u>. All students are advised to have a personal Computing platform/ Laptop/ Notebook computer, as they will have to attend some of classes in online mode even after everything gets normal.
