

M Tech 2021-22 Registration Process

Dear Students,

Welcome to Indian Institute of Information Technology Vadodara. Congratulations for a new phase in your life. This letter provides you guidelines to complete admission process and start of academic process at IIIT Vadodara

Please read the following instructions carefully and follow the same

1. Reporting :

You have been allotted IIIT Vadodara through the process of admission conducted by the Centralized Counselling for M Tech (CCMT - 2021)

- Due to COVID-19 pandemic, all academic activities will be conducted online initially. This will continue till conditions are conducive to student presence at institute.
- At IIIT Vadodara online class will be held with Google Classroom along with Google Meet platforms. Any change will be intimated to you at appropriate time.
- Every student will be required to have her/his own computer (desktop / laptop / notebook) to carry out all the academic activities including classes, labs, assignments. The computing hardware will also be require for teaching assistanceship (TAsip) duties allotted by the Institute.
- Hence, it is essential to have own laptop/ computer to meet the academic requirements. Tab based hardware can be used but will pose a major limitations in work. Mobile phone will not be adequate.
- The classes for the M Tech-2021 batch shall begin from September 20, 2021 (Monday) 08:00AM onward.
- Detailed time-table and Google Meet link(s) for the class shall be communicated in due course.
- Only upon official notice from Institute, you will have to report physically and join the academic activities from the institute premises. You will be assigned teaching assistanship during orientation process.

2. Documents:

You will be required to bring the following documents for verification, while physically reporting at the Institute upon receiving official notification from the Institute authority only. Till that time your admission is provisional.

- (a) Printout of the Registration form and the locked choices.
- (b) Provisional Seat Allotment letter downloaded from the CCMT website
- (c) Self-attested copy of GATE scorecard (2019 or 2020 or 2021)
- (d) Photo ID proof as per Govt. of India norms
- (e) Original Birth certificate
- (f) Original Mark sheet of Class XII
- (g) Original Grade/Mark sheets of qualifying examination for all semesters
- (h) Original Degree/ Provisional certificate, if degree is awarded.

- (i) Original Certificate of reservation category (SC/ST/OBC), if applicable, as per Government of India notification, issued by the competent authority. in case of OBC category the certificate must be issued on or after April 1, 2021. Caste certificate of category (SC/ST/OBC) issued by Maharashtra state must be validated by Social Welfare Department (in case of ST category) of Maharashtra Government.
- (j) Undertaking by the candidate regarding OBC status in the required format
- (k) Original Certificate for Persons with Disabilities (PwD), if applicable, issued by the competent authority
- (l) Proof of payment of full fee of Rs. 54,870/- to CCMT.
- (m) Original Migration certificate of last Institute / University attended
- (n) Three colour passport size photographs
- (o) Original Conduct Certificate from the Head of the institution last attended
- (p) Original college leaving certificate/ Transfer certificate from the Head of the institution last attended
- (q) Original Course completion certificate from the Head of the University / Institute in case result is awaited in absence of degree certificate.
- (r) One set of self-attested photocopy of all the original documents.
- (s) Medical fitness certificate (Issued by a registered medical practitioner (Format attached)).
- (t) Copy of Anti-ragging undertaking by Student and Parent.

4. Payment of Transport, Hostel and Mess Fees:

Notes:

1. It is essential for students to get vaccinated for Covid-19. You are advised to complete the vaccination as and when available. This will be a requirement for reporting at campus.
2. Hostel and Mess fees are to be paid to the respective vendors after reporting process of the Institute. **Hostel is mandatory for 1st year M.Tech students.**
3. Transport, Hostel and Mess fees will be charged only if the student reports physically for the classes at the Institute.
3. Tuition Fee will remain the same for the batch, however it is expected that the sum total of other fees would increase by appx 10% every year.
